## Sex offender arrested on exploitation charges

Tuesday, Nov. 15, 2022

**NORTH CHARLESTON, S.C.** – Following an investigation, detectives from the Charleston County Sheriff's Office on Tuesday arrested Jeffrey Allen Miller, 64, of Macoma Drive in the Mount Pleasant area on two counts of second-degree sexual exploitation of a minor. He was booked at the Al Cannon Detention Center.

Miller is a registered sex offender.

AFFIDAVIT

Personally appeared before me, a magistrate of this County, one J. Bowen, who, first being duly sworn, deposes and says that

**Jeffrey Allen Miller**

did, within this County and State on September 10, 2022, violate the criminal laws of the State of South Carolina in the following particulars:

**Sexual Exploitation of a Minor, 2nd Degree  
16-15-405**

The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

That on September 10, 2022, the above named defendant, **Jeffrey Allen Miller**, did commit the offense of violation section **16-15-405** of the South Carolina Code of Laws, 1976 as amended, **Second Degree Sexual Exploitation Of A Minor**, in that he did willfully, unlawfully, and knowing the character or content of the material, distribute a digital electronic file that contained a visual representation of a minor engaging in sexual activity or appearing in a state of sexually explicit nudity when a reasonable person would infer the purpose is sexual stimulation.

On September 19, 2022, Detective Bowen, who is a member of the SC ICAC task force, received cyber-tip number \_\_\_\_\_, via the ICAC task force, in reference to the sexual exploitation of a minor. On September 10, 2022, a user of an email provider had transmitted a photo that depicted a female child who was approximately 11-14 years old. The child was completely nude. She was sitting on the legs / torso of an apparent adult male who was lying on his back. The adult male's penis was nude and erect. The child was touching the adult's penis and appeared to be masturbating him. The name of this file was \_\_\_\_\_ The defendant emailed the file to himself via the email reported in the cybertip. This action created a copy of the reported file and gave the defendant ready access to the file in a form that would be easy to distribute in the future. The image was transmitted from an email account that was registered to the defendant. The email account utilized a phone number and IP address assigned to the defendant. The defendant had previously registered the reported email address as part of his convicted sex offender registration.

This information is known through the investigation of Detective J. Bowen of the Charleston County Sheriff's Office, and of the South Carolina ICAC task force, and he is witness to prove the same against the form of the statute in such case made and provided against the peace and dignity of the State.



The child was lying on her back and was completely nude. The nude, erect, penis of an apparent adult was in the frame of the photo above and at the child's nude vagina. The name of this file was \_\_\_\_\_. The image was transmitted from an email account that was registered to the defendant. The email account utilized a phone number and IP address assigned to the defendant. The defendant had previously registered the reported email address as part of his convicted sex offender registration.

This information is known through the investigation of Detective J. Bowen of the Charleston County Sheriff's Office, and of the South Carolina ICAC task force, and he is witness to prove the same against the form of the statute in such case made and provided against the peace and dignity of the State.
