CCSO arrests man, 55, in sex assault, trafficking of teen

NORTH CHARLESTON, S.C. – Charleston County Sheriff's Office detectives have arrested a 55-year-old man on six charges related to the sexual assault, exploitation and trafficking of a teenage girl.

David William Hollars of Palm Cove Drive in Charleston faces charges of trafficking in persons under 18, criminal solicitation of a minor and two counts each of first-degree sexual exploitation of a minor and second-degree criminal sexual conduct with a minor. He also faces charges from the Charleston Police Department.

"This is an incredibly disturbing case," Charleston County Sheriff Kristin Graziano said. "Our investigation is ongoing, as we continue to follow leads and information in the case. Our hearts go out to the victim, and we have made ourselves available to her and her family as she begins her recovery from this trauma. No child should ever go through this."

A parent of the 15-year-old victim reported the crimes to CCSO in late March. The ensuing investigation showed that the girl was 14 when she met Hollars through the messaging app Snapchat. CCSO detectives found evidence of text messages containing sexually explicit conversations. The victim also described multiple meetings involving sexual contact and instances of Hollars providing money or items in exchange for sexual contact.

The investigation expanded to other jurisdictions. On Monday, Charleston police officers and CCSO deputies, along with personnel from Homeland Security Investigations and the Attorney General's Office, searched Hollars' home in Berkeley County. He was arrested by Charleston police on charges involving the same victim and booked at the Hill-Finklea Detention Center. Please contact CPD for information regarding its charges.

Hollars was transferred and booked Wednesday at the Al Cannon Detention Center on the CCSO charges.

The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

That on March 18, 2023, the above named defendant, DAVID WILLIAM HOLLARS, did commit the offense of violation section 16-15-395 of the South Carolina Code of Laws, 1976 as amended, First Degree Sexual Exploitation Of A Minor, in that he did willfully, unlawfully, and knowingly encourage what Hollars knew to be a minor to appear in a state of sexually explicit nudity, as defined by Section 16-15-375 of the South Carolina Code of Laws, 1976 as amended, for the purpose of producing material that contains a visual representation depicting this nudity. Hollars was 55 years old at the time of this request. This encouragement was via electronic communication to the minor while the minor was located in Charleston County, South Carolina.

On April 4, 2023, I reviewed the cell phone download of the victim's cell phone. On March 18, 2023, at approximately 1322 hours UTC time Detective Jacko located text messages that were sent between the child victim and the defendant. The defendant sent a text to the child victim saying, "I think about when you were at my house and how good it was." The defendant then says to the child victim "Sometimes I go back and watch your videos! So hot!" Later on in the conversations, the defendant says to the child victim "I have played with myself so many times watching them." The child victim says to the defendant "Why don't you just text me for new ones? Haha." The defendant then says to the child victim "I would love some new ones!! Especially with you fucking your toy!" The child victim disclosed during a forensic interview that the defendant bought and gave her sex toys to masturbate with. The cell phone number that the defendant is using is also registered to the defendant.

This information is known through the investigation of Detective J. Jacko of the Charleston County Sheriff's Office, and of the South Carolina ICAC task force, and he is witness to prove the same against the form of the statute in such case made and provided against the peace and dignity of the State.

On April 4, 2023, I reviewed the cell phone download of the victim's cell phone. On March 18, 2023, at approximately 1322 hours UTC time Detective Jacko located text messages that were sent between the child victim and the defendant. The defendant asked the child victim to appear in a state of sexually explicit nudity with sex toys that he provided her. The child victim disclosed during a forensic interview that the defendant bought and gave to her sex toys to masturbate with. On March 19, 2023, at approximately 2135 hours UTC time the defendant again asked her to produce another video. The cell phone number that the defendant is using is also registered to the defendant.

This information is known through the investigation of Detective J. Jacko of the Charleston County Sheriff's Office, and of the South Carolina ICAC task force, and he is witness to prove the same against the form of the statute in such case made and provided against the peace and dignity of the State.

The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

That on March 18, 2023, the above named defendant, DAVID WILLIAM HOLLARS, did commit the offense of violation section 16-15-342 of the South Carolina Code of Laws, 1976 as amended, Criminal Solicitation Of A Minor, in that he did willfully, unlawfully, and knowingly contact or communicate with, a person who he believed was under the age of eighteen, for the purpose of, or with the intent of, persuading, inducing, enticing, or coercing the person to engage or participate in a sexual activity as defined in Section 16-15-375(5).

On April 4, 2023, Detective Jacko, who is a member of the SC ICAC task force, reviewed the cell phone download of the child victim. The child victim stated that she told the defendant that she was under the age of 18 when they met on Snap Chat. Upon review of the cell phone download of the child victim, Detective Jacko located a string of text messages dated March 18, 2023, the defendant engaged the child victim in a sexually explicit conversation in which he graphically described the sexual activity he wanted to engage the child victim in. This included telling the child victim that he would "love to bend her over and pound her really hard until he explodes and fill her up with daddy's cum, then do it again and again." Later on, in the conversation the defendant states that they "would have amazing sex all night." During a forensic interview of the child victim at a later date she stated that the defendant has picked her up from her high school that she was attending at the time. The victim was 15 years old when this text message was sent, and the defendant was 55 years old.

Jacko of the Charleston County Sheriff's Office, and of the South Carolina ICAC task force, and he is witness to prove the same against the form of the statute in such case made and provided against the peace and dignity of the State.

The victim stated that they had penial to vaginal sexual intercourse during this incident. The defendant then went to the gas station near her residence and brought her snacks and then took her back to her residence. The defendant was 55 years old during this incident and the victim was 15 years old.

The victim stated that the defendant told her to get into the back seat of the truck when he came to the residence and to take off her pants. The victim took off her pants and they had sexual intercourse. After the incident occurred the defendant gave the child victim \$200 via Cash App. The defendant was 55 years old during this incident and the victim was 15 years old. The defendant had prior knowledge of the child's victim age prior to this encounter. During the forensic interview the child victim stated that the defendant had previously sent the child victim money for transportation to his residence, money for clothing, and purchased sex toys and food, which are items of value for her in exchange for sexual contact.
